Motions are forms of parliamentary procedure that provide information on a matter which is then read aloud to the body. If the motion is "submitted," the matter is then given consideration. If the motion is "seconded," the chair can direct the body to deliberate on it or debate the motion. The chair can suspend debate, order voting on the motion, or close debate at any time during the meeting. Roberts Rules of Order advises the use of the United States Constitution, the federal and state constitutions, and the United States Code as guides. However, each state has its own constitution, and each state has its own laws and regulations. Therefore, Roberts Rules of Order does not cite to every state's laws and regulations, but only to those that cover the context of the discussion or procedure being presented. Therefore, each state has the authority to enact its own laws and regulations when necessary. When citing a state's laws and regulations, it is critical to be aware of those laws and regulations that are in effect at the time of the meeting and the location of the meeting, or else the laws and regulations may be different than those cited.
